ORDER

The Writ Petition has been filed to direct the respondents to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Sivasakthi Mariamman Temple Festival” Adiyamankottai Village, Adiyamankottai Post, Nallampalli Taluk, Dharmapuri District, on 03.03.2023 at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 24.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Sivasakthi Mariamman Temple Festival” Adiyamankottai Village, Adiyamankottai Post, Nallampalli Taluk, Dharmapuri District, on 03.03.2023, the petitioner has sent a representation, dated 24.02.2023 to the respondent Police.
