The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the

Maha Kumbabishekam Festival at Rasipuram Taluk, Namakkal District on 03.03.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 22.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Pachudaiyampalayam Village Arulmigu Sree Mariyamman Temple Maha Kumbabishekam Festival at Rasipuram Taluk, Namakkal District on 03.03.2023 between 06.00.p.m to 11.00.p.m., the petitioner has sent a representation dated 22.02.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.
