ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Sri Kali Amman Temple at Koratti Village, Tirupattur Taluk, Vellore District – 635 602. on 04.03.2023, at 7.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 25.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Sri Kali Amman Temple at Koratti Village, Tirupattur Taluk, Vellore District – 635 602 on 04.03.2023, the petitioner has sent a representation, dated 25.02.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
