## **ORDER**

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Temple Festival of Arulmigu Sri Maga Mariamman Temple, Thippambatti Village, Panamarathupatti Taluk, Salem District , on 09.03.2023, at 6.00 P.M. onwards by considering the petitioner's representation dated 23.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Temple Festival of Arulmigu Sri Maga Mariamman Temple, Thippambatti Village, Panamarathupatti Taluk, Salem District, on 09.03.2023, the petitioner has sent a representation, dated 23.02.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
