ORDER

The Writ Petition has been filed for directing the respondent to grant permission and necessary protection to conduct the Adal Padal program on 25.03.2023 at 06.00p.m to 10.00p.m in connection with Maha Kumbabhishekam Thiru Vizha of Sri Renukadevi Ellamma Devi Temple, at Komaranapalli village, Pelakondapalli Post, Thali ondiryam, Krishnagiri District through consider petitioner's requisition letter dated 17.02.2023 on merits and dispose off the same in accordance with law.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Maha Kumbabhishekam Thiru Vizha of Sri Renukadevi Ellamma Devi Temple, at Komaranapalli village, Pelakondapalli Post, Thali ondiryam, Krishnagiri District on 25.03.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 17.02.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai, had issued a Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 17.02.2023 and pass suitable orders based on the above said circular.
