ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Arulmighu Sri Mahamariamman Kovil at Sathirappatti Kolanalli Post, Kodamudi Taluk, Erode District on 08.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 07.02.2023.
