ORDER

The Writ Petition has been filed to direct the respondents to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Angalaparameswari Amman Temple Mayanakollai festival” Thuvarandal village, Kalkuppam Post, Polur Taluk, Tiruvannamalai District on 12.03.2023 at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 24.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Angalaparameswari Amman Temple Mayanakollai festival” Thuvarandal village, Kalkuppam Post, Polur Taluk, Tiruvannamalai District on 12.03.2023, the petitioner has sent a representation, dated 24.02.2023 to the respondent Police. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 24.02.2023 and pass suitable orders based on the above said circular.
