The respondent police is directed to consider the petitioner's representation dated 23.02.2023 in light of the detailed Circular Memorandum in Rc.007301/Genl.I(1)/2019, dated 09.04.2019 issued by the Director General of Police, Tamil Nadu, Chennai, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme and to pass suitable orders based on the above said circular.

5. With the above direction, this Writ Petition is disposed of. No costs.
