ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Panamarathupatti Arulmigu Sree Mariyamman Temple Festival at Salem Taluk & District on 08.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 25.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Panamarathupatti Arulmigu Sree Mariyamman Temple Festival at Salem Taluk & District on 08.03.2023, the petitioner has sent a representation, dated 25.02.2023 to the respondent Police.
