ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Sri Thottiyathu Mariamman Kovil at Pallakuttapatti Village, Semmankoodal Post, Omalur, Salem District on 07.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 07.02.2023.
