Prayer in W.P.No.7613 of 2023: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records on the files of the respondent in TNGST.2400490/ 2002-03 dated 24.01.2023 and quash the same as being without jurisdiction and arbitrary and hence invalid and illegal and further directing the respondent to pass orders afresh granting concessional rate of tax under Section 3(3) of the Tamil Nadu General Sales Tax Act.

Prayer in W.P.No.7617 of 2023: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records on the files of the respondent in TNGST.2400490/ 2003-04 dated 24.01.23 and quash the same as being without jurisdiction and
