### **ORDER**

The Writ Petition has been filed to directing the first and second respondents to give permission and police protection to conduct Cultural programme (Adal Padal Nigalchi) in the event of Sri Mariamman Temple festival Thottiyapalayam Village, Kalpavi Post, Bhavani Taluk, Erode District on 10.03.2023 between 06.00PM to 11.00PM by considering the petitioners representation dated 24.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Sri Mariamman Temple festival Thottiyapalayam Village, Kalpavi Post, Bhavani Taluk, Erode District on 10.03.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 24.02.2023 to the respondents. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 24.02.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
