Thereafter, he was transferred to the respondent Corporation and directed to work as Heavy Vehicle Driver. While being so, on 30.05.2011, he was relieved from the Headquarters and he was directed to report before the Branch Manager, K.K.Nagar Bus Station. Therefore, he was seeking to retain him as Light Transport Vehicle Driver. Now, the petitioner retired from service and as such, the prayer sought for in this writ petition has become infructuous.

4. In view of the above, this writ petition stands dismissed. There shall be no order as to costs.
