ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Chinna Mattarapalli Village Arulmigu Sree Govindarajulu Swamy Temple Festival at Bargur Taluk, Krishnagiri District on 11.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 25.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Chinna Mattarapalli Village Arulmigu Sree Govindarajulu Swamy Temple Festival at Bargur Taluk, Krishnagiri District on 11.03.2023, the petitioner has sent a representation, dated 25.02.2023 to the respondent Police.
