The Writ Petition has been filed to direct the respondent to grant permission to conduct the cultural programme of Adal Padal on 11.03.2023 between 07.30 p.m. to 10.30 p.m. at “Sri Gangai Mariamman Temple Tidal at Vattamuthampatti Village, Sarkar Kollappti Post, Salem west Taluk, Salem District – 636030, by considering the petitioner's representation dated 28.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Gangai Mariamman Temple Tidal at Vattamuthampatti Village, Sarkar Kollappti Post, Salem west Taluk, Salem District – 636030 on 11.03.2023 between 07.30 p.m. to 10.30 p.m., the petitioner has sent a representation dated 28.02.2023 to the respondent.
