3. Learned counsel for the petitioner submits that the petitioner has been absorbed in respondent-University with effect from 08.07.2014 by proceedings dated 22.10.2021. Learned counsel further submitted that in view of the proceedings dated 22.10.2021 issued by the respondent-University, this writ petition can be closed, with a liberty to challenge the action of the respondent for not giving effect from 01.08.2012 to the petitioner.
