The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Thippampatti Village Arulmigu Sree Sakthi Mariyamman Temple Maha Kumbabishekam Festival at Mettur Taluk, Salem District on 24.03.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 28.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Thippampatti Village Arulmigu Sree Sakthi Mariyamman Temple Maha Kumbabishekam Festival at Mettur Taluk, Salem District on 24.03.2023 between 06.00.p.m to 11.00.p.m., the petitioner has sent a representation dated 28.02.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 28.02.2023 and pass suitable orders based on the above said circular.
