2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Manickampalayam, Mettupudur Arulmigu Sree Mariyamman temple Festival at Tiruchengaldi Taluk, Namakkal District on 13.04.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 28.02.2023 to the respondent.
