2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "Sri Pattai Sarathi Amman Temple festival Kuppambattu Village, Veppankuppam Post, Anaicut Taluk, Vellore District on 08.03.2023 between 06.00.p.m to 11.00.p.m., the petitioner has sent a representation dated 03.03.2023 to the respondent.
