2. The petitioner is the wife against whom the respondent/husband filed a petition in FCOP.No.88 of 2023 on the file of the Family Court, Erode seeking for divorce. 5. Accordingly, this Tr.C.M.P.No.257 of 2023 is allowed. There shall be no order as to costs. Consequently, connected miscellaneous petition is closed.
