ORDER

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Mariamman Temple Festival” Chinnapudur, Hasthampatti Post, Salem Taluk, Salem District, on 11.03.2023, the petitioner has sent a representation, dated 03.03.2023 to the respondent Police.
