The Writ Petition has been filed to direct the respondent to grant permission to conduct the cultural programme of Adal Padal on 18.03.2023 at 06.00 PM to 11.00 PM at "Sri Sakthi Mariamman Temple Maha Kumbhabhisekham festival" Thoppur Village, Damodarahalli Post, Pochampalli Taluk, Krishnagiri District, by considering the petitioner's representation dated 03.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "Sri Sakthi Mariamman Temple Maha Kumbhabhisekham festival" Thoppur Village, Damodarahalli Post, Pochampalli Taluk, Krishnagiri District on 18.03.2023 between 06.00.p.m to 11.00.p.m., the petitioner has sent a representation dated 03.03.2023 to the respondent.
