The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of "Sri Kasiswara, Basaveshwara, Sivakumaraswamy Temple Festival" Avalnattham Village, Sennasandiram Post, Krishnagiri Taluk, Krishnagiri District on 13.03.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 03.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "Sri Kasiswara, Basaveshwara, Sivakumaraswamy Temple Festival" Avalnattham Village, Sennasandiram Post, Krishnagiri Taluk, Krishnagiri District on 13.03.2023 between 06.00.p.m to 11.00.p.m., the petitioner has sent a representation dated 03.03.2023 to the respondent.
