ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Ponparappipatti Colony Arulmigu Sree Chinna Mariyamman Temple Festival at Rasipuram Taluk, Namakkal District on 11.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 01.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Ponparappipatti Colony Arulmigu Sree Chinna Mariyamman Temple Festival at Rasipuram Taluk, Namakkal District on 11.03.2023, the petitioner has sent a representation, dated 01.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
