ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Nadukombai Village, Samikadu Arulmigu Sree Nachiyamman Temple Festival at Sendamangalam Taluk, Namakkal District on 14.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 02.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Nadukombai Village, Samikadu Arulmigu Sree Nachiyamman Temple Festival at Sendamangalam Taluk, Namakkal District on 14.03.2023, the petitioner has sent a representation, dated 02.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Criminal side) appearing for the respondents submitted that the respondent police has received the
