The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of "Sri Veeramaniyappan Temple festival" Periyapannimaduvu Village, Mampatti Post, Harur Taluk, Dharmapuri District on 09.03.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 04.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "Sri Veeramaniyappan Temple festival" Periyapannimaduvu Village, Mampatti Post, Harur Taluk, Dharmapuri District on 09.03.2023 between 06.00.p.m to 11.00.p.m., the petitioner has sent a representation dated 04.03.2023 to the respondent.
