ORDER

This Criminal Original Petition has been filed to direct the third respondent police to file the final report pending in Crime No.394 of 2022 on the file of the respondent Police against the accused in a time bound manner.

2.When the matter is taken up, the learned counsel appearing for the petitioner would submit that though the respondent has registered a case in Crime No.394 of 2022, no final report has been filed till date. Hence, the present petition has been filed.

3.The learned Government Advocate (Criminal Side) submitted that, based on the complaint lodged by the petitioner, the respondent police has registered the FIR in Crime No.394 of 2022, in which, investigation is under progress. Hence, he seeks three months time to file a final report before the Jurisdictional Magistrate Court.
