ORDER

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Mariamman and Sri Kaliamman Temple Festival” Kandampatti Colony, Suramangalam Post, Salem Taluk, Salem District, on 11.03.2023, the petitioner has sent a representation, dated 04.03.2023 to the respondent Police.
