ORDER

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Pathrakaliamman Temple Festival” Kullampatti Village, Kullampatti Post, Arasiramani, Sankagiri Taluk, Salem District, on 10.03.2023, the petitioner has sent a representation, dated 04.03.2023 to the respondent Police.
