ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Thottiyathu Mariamman Temple Festival” Palakuttapatti Muthunaickenpatti Omalur Taluk, Salem District, on 11.03.2023, by considering the petitioner's representation dated 07.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event “Sri Thottiyathu Mariamman Temple Festival” Palakuttapatti Muthunaickenpatti Omalur Taluk, Salem District, on 11.03.2023, the petitioner has sent a representation, dated 07.03.2023 to the respondent Police.
