ORDER

The Writ Petition has been filed to direct the respondent to give permission to conduct Cultural programme (Adal Padal Nigalchi) in the event of Pichanur Village Arulmigu Sree Maha Mariyamman Temple Festival at Bhavani Taluk Erode District on 06.04.2023 between 06.00PM to 11.00PM by considering the petitioners representation dated 03.03.2023

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Pichanur Village Arulmigu Sree Maha Mariyamman Temple Festival at Bhavani Taluk Erode District on 06.04.2023 between 06.00PM to 11.00PM, the petitioner has sent a representation dated 03.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 03.03.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
