ORDER

The Writ Petition has been filed to direct the respondents to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of “Sri Sakthi Mariamman Temple and Sri Mooppanaar Temple Tidal” at Mallamooppampatti Village, Kakkan colony, Salem west Taluk, Salem District on 17.03.2023 at 7.30 P.M. to 10.30 P.M, by considering the petitioner's representation dated 08.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Sakthi Mariamman Temple and Sri Mooppanaar Temple Tidal” at Mallamooppampatti Village, Kakkan colony, Salem west Taluk, Salem District on 17.03.2023, the petitioner has sent a representation, dated 08.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
