The petitioner agrees to settle the respondents 2 and 3 to a tune on one lakhs each and the same is also accepted by the respondents 2 & 3 and the petitioner pay Rs.1,00,000/- (One Lakhs only) to both the respondent by way of Cheque No.291033, Indian Bank, Ariyankuppam Branch, Puducherry to 2nd respondent Rajendiran and Cheque No.291034, Indian Bank, Ariyankuppam Branch, Puducherry to 3rd respondent Ravi @ Ramasamy. Therefore, in pursuant to this joint compromise entered between the parties all disputes are hereby resolved amicably.
