ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Oosinattan Village Arulmigu Sree Vembalamarathu Mariyamman Temple Festival at Tirupathur Taluk & District, on 22.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 06.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Oosinattan Village Arulmigu Sree Vembalamarathu Mariyamman Temple Festival at Tirupathur Taluk & District, on 22.03.2023, the petitioner has sent a representation, dated 06.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
