ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Arisipalayam Arulmigu Sree Sulukku Pillaiyar Mariyamman Temple Festival at Salem Taluk & District, on 17.03.2023, at 6.00 P.M. to 11.00 P.M., by considering the petitioner's representation dated 08.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Arisipalayam Arulmigu Sree Sulukku Pillaiyar Mariyamman Temple Festival at Salem Taluk & District, on 17.03.2023, the petitioner has sent a representation, dated 08.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
