The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct Cultural programme (Adal Padal Nigalchi) in the event of Erode, Choolai, M.G.R.Nagar Arulmigu Sree Selva Muthu Mariyamman Temple Festival at Erode Taluk & District on 05.04.2023 between 6 PM to 11 PM by considering the petitioner's representation dated 09.03.2023.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 09.03.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
