ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Sri Arulmighu Nadupalani Sri Dhandayuthapani Swami Devasthanam 59th year Panguni Uthira Thiruvizha, Deeverahalli, Pochampalli, Krishnagiri District on 01.04.2023 to 05.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 07.02.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Sri Arulmighu Nadupalani Sri Dhandayuthapani Swami Devasthanam 59th year Panguni Uthira Thiruvizha, Deeverahalli, Pochampalli, Krishnagiri District on 01.04.2023 to 05.04.2023, the petitioner has sent a representation, dated 07.02.2023 to the respondent Police. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 07.02.2023 and pass suitable orders based on the above said circular.
