The Writ Petition has been filed to direct the first and second respondent to grant permission to conduct the cultural programme of Adal Padal on 30.03.2023 at 06.00 PM to 11.00 PM at "Sri Thammaraya Swamy Temple Festival" Badapalli Village, Badapalli Post, Uthangarai Taluk, Krishnagiri District by considering the petitioner's representation dated 10.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of "Sri Thammaraya Swamy Temple Festival" Badapalli Village, Badapalli Post, Uthangarai Taluk, Krishnagiri District on 30.03.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 10.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 10.03.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
