ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Salaipudur Village Arulmigu Sree Kaliyamman Temple Festival at Kodumudi Taluk, Erode District, on 29.03.2023, at 6.00 P.M. to 11.00 P.M., by considering the petitioner's representation dated 11.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Salaipudur Village Arulmigu Sree Kaliyamman Temple Festival at Kodumudi Taluk, Erode District, on 29.03.2023, the petitioner has sent a representation, dated 11.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
