ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Sri Sellandiyamman, Sri Mariyamman Thiru Kovil at Napalaiyam, Edanganasalai Post, Sankagiri Taluk, Salem District on 06.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 07.02.2023.
