The Writ Petition has been filed for directing the respondent to grant permission to conduct cultural Programme Sri Arulmigu Mahasakthi Mariamman Temple scheduled to be held on 20.03.2023 at Pagalaahalli

District by considering the petitioner's representation dated 14.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Programme Sri Arulmigu Mahasakthi Mariamman Temple at Pagalaahalli Panchayat, Dhandukarampatti Village, Nallampalli Taluk and Dharmapuri District scheduled to be held on 20.03.2023 between 6 PM to 11 PM, the petitioner has sent a representation dated 14.03.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Crl.side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

5. It is brought to the notice of this Court that the Director General of
