ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Asakalathur Arulmigu Sree Angalamman Temple Festival at Kallakurichi Taluk & District on 25.03.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 11.03.2023.
