The Writ Petition has been filed for directing the respondent to give permission and police protection to conduct Cultural Programme (Adal Padal Nigalchi) in the event of Pagalpatti Tholur Arulmigu Sree Madura Sengali Amman Temple Festival at Omalur Taluk Salem District on 07.04.2023 between 06.00PM to 11.00PM by considering the petitioners representation dated 13.03.2023.
