ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Kaadakkaranur Village, Motturkadu Arulmigu Sree Azhagu Muthu Mariyamman Temple Festival at Omalur Taluk, Salem District on 07.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 13.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Kaadakkaranur Village, Motturkadu Arulmigu Sree Azhagu Muthu Mariyamman Temple Festival at Omalur Taluk, Salem District on 07.04.2023, the petitioner has sent a representation, dated 13.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 13.03.2023 and pass suitable orders based on the above said circular.
