ORDER

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of “Sri Angalamman Temple Festival” Varadampattu Village, Varadampattu Post, Anaicut Taluk, Vellore District, on 29.03.2023, the petitioner has sent a representation, dated 13.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
