ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Vengampatti Village Arulmigu Sree Poovayamman Temple Festival at Salem Taluk & District on 14.04.2023, at 6.00 P.M. to 11.00 P.M, by considering the petitioner's representation dated 15.03.2023.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Vengampatti Village Arulmigu Sree Poovayamman Temple Festival at Salem Taluk & District on 14.04.2023, the petitioner has sent a representation, dated 15.03.2023 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
