2. It is the submission of the learned counsel for the petitioner that the petitioner has been cheated by one Cheenu @ Seenivasan in lending a chit to the tune of Rs.2 Crores and 20 Lakhs. In this regard, he gave a complaint to the first respondent on 10.10.2018, seeking preliminary enquiry, as per the direction of the Hon'ble Apex Court in Lalita Kumari case.
