ORDER

This Writ Petition has been filed to direct the respondent to give permission and police protection to conduct cultural programme (Adal Padal Nigalchi) in the event of Amman Kattur Village Arulmigu Sree Sakthi Mariyamman Temple Festival at Edapadi Taluk, Salem District on 09.04.2023 between 06.00 P.M to 11.00 P.M by considering the petitioner's representation dated 15.03.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of ***Amman Kattur Village Arulmigu Sree Sakthi Mariyamman Temple Festival at Edapadi Taluk, Salem District on 09.04.2023 between 06.00 P.M to 11.00 P.M, the petitioner has sent a representation dated 15.03.2023*** to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated **15.03.2023** and pass suitable orders based on the above said circular.
