The petitioner has filed this writ petitioner seeking for a direction to the respondent to consider the Representation/Proposal dated 02.02.2023 of the petitioner college seeking sanction of 3 additional/new posts in the Department of Arabic in the light of approval given by the first respondent to the similar college for 3 additional posts in the department of physics vide proceedings Na.Ka.41529/G2/2017 dated 21.07.2022.

3. The case of the petitioner College, is that the petitioner college is having a sanctioned strength of 10 Assistant professors post in Arabic Department as per proceedings in Pa.Mu.54998/G1/99 dated 28.10.1999. The grievance of the petitioner College is that the University of Madras was also granting affiliation to B.A. Arabic Course to the petitioner's College, due to which there was enormous increase in work load and in the student strength, therefore petitioner college submitted a detailed representation regarding the issue to the first respondent on 02.02.2023. However, the same has not been considered which leads to the filing of this writ petition.

4. The learned counsel for the petitioner submits that for the similarly placed colleges the first respondent has given approval. Hence prays this Court to consider the petitioner's representation dated 01.02.2021 and pass appropriate orders within a reasonable time fixed by this Court.

5. The Government Advocate would submit that the petitioner's representation will be considered on merits and in accordance with law within a time frame as fixed by this Court.
