(3) Copies of all records relied upon by the 2nd respondent for passing the award under Section 3G(1) of the National Highways Act, 1956,

(4) strictly follow the provisions of Sections 26 to 30 and procedure contemplated in First Schedule of the Central Act 30 of 2013 and grant opportunity to the petitioner for filing further written submissions and thereafter pass final award under Section 3G(5) of the National Highways Act, 1956 for determining the compensation for the land measuring 536 sq.mtrs. (13.25 cents) in S.No.418/3B1 and 171 sq.mtrs. (4.25 cents) in S.No.418/4A1B in all measuring 17.5 cents situated in A.Reddihalli Village, Dharmapuri Taluk, covered in joint patta No.1241.
